ORDINANCE NO. 476

AN ORDINANCE AMENDING TITLE 3, CHAPTER 1 OF THE MORRISON MUNICIPAL CODE CONCERNING BUSINESS LICENSES

WHEREAS, the Town of Morrison is a Colorado home rule municipality operating under a Charter approved by the electorate pursuant to Article XX of the Colorado Constitution and governed by its elected Board of Trustees; and

WHEREAS, the Board of Trustees has authority pursuant to the Home Rule Charter and C.R.S. §31-16-101, et seq. to adopt and enforce all ordinances; and

WHEREAS, the Board of Trustees desires to amend Title 3, Chapter 1 of the Morrison Municipal Code concerning business licenses.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Morrison, Colorado

Section 1. Amend Section 3-1-1 License required; Exemptions by deleting last sentence as follows:

The town administrator shall be responsible for determining the application of this section with right of appeal to the board of trustees of any decision.

Section 2. Amend Section 3-1-2 Application of Provisions by deleting last sentence as follows:

The licensing provisions of this chapter shall apply only to the owners or operators of said business except as otherwise provided, and employees of the owners or operators of said business are not required to be licensed. The town administrator shall have authority to determine whether or not a particular person is an employee or an operator or owner of such a business. The decision of the town administrator may be appealed to the board of trustees.

- <u>Section 3.</u> Amend Section 3-1-4 Requirements to delete subsection A and re-letter remaining subsections as follows
 - **3.1.4:** Requirements: No license shall be issued until the following areas have been considered in accordance with applicable directives of the board of trustees:
 - A. Character and background of applicant;
 - A. Physical condition and right to use of the premises where the business is to be conducted;
 - B. Zoning;

- C. Proper utility connections;
- D. Compliance with health and sanitation requirements;
- E. Other factors deemed necessary for the protection of the public health, safety and welfare.

Section 4. Amend Section 3-1-9 Short Term and Special Events Licenses; Permits as follows:

Amend first paragraph of subsection B to read:

B. Special Events License: There shall be a special events license. for activities involving ten (10) or more vendors lasting no more than three (3) days. Such license shall be available for festivals, trade shows, craft or other fairs, bazaars and other activities of a similar nature. The fee for such license shall be determined as follows:

Re-letter existing subsection C as D and add new subsection C to read:

C. THE TOWN MANAGER, IN HIS OR HER SOLE DISCRETION MAY, WITH OR WITHOUT A RECOMMENDATION, REFER ANY SHORT TERM OR SPECIAL EVENT LICENSE APPLICATION TO THE BOARD OF TRUSTEES FOR DECISION.

Section 5. Amend Section 3-1-9.D.2 to read as follows:

2. Notification To State Licensing Authority: In accordance with section 12-48-107(5)(a), Colorado Revised Statutes, the town elerk MANAGER or her THEIR designee shall report to the liquor enforcement division within ten (10) days after a special event permit is approved, the name of the organization to whom a permit was issued, the address of the permitted location and the permitted dates of alcohol beverage service.

Section 6. Amend Section 3-1-10.C by deleting subparagraph 4, which reads:

4. Such other information as may be required from time to time by direction of the board of trustees.

Section 7. Severability. If any article, section, paragraph, sentence, clause or phrase of this ordinance, or the standards adopted herein is held to be unconstitutional or invalid for any reason, such decision will not affect the validity or constitutionality of the remaining portions of this ordinance. The Board of Trustees hereby declares that it would have passed this ordinance and each part hereof irrespective of the fact that any one part or parts are declared unconstitutional or invalid.

<u>Section 8</u>. Effective Date. This ordinance shall take effect fifteen (15) days after adoption and publication as provided by Section 3.14 of the Home Rule Charter.
